Beach Cleanups & Protect Marine Animal

"Save the Marine Life"

Currently, the challenges we face resemble the action-reaction mechanisms of nature, with humans being solely responsible for various forms of pollution. The cleanliness of beaches is crucial, as any garbage or plastic waste not properly disposed of can contaminate the sea, adversely impacting the lives of aquatic animals.

The initiative 'For Future India' commenced in January 2020, and to date, we have organized cleanup efforts at Uttan Beach, Velankanni Beach, Gorai Beach, Manori Beach, with the participation of over 85,000 volunteers in 270+ cleanup sessions. Our collective efforts have successfully removed approximately 18,50,000+ kg of waste and plastic materials.

Over the past four years, consistent weekly cleanup drives and awareness programs have led to visible improvements on the beaches and in the Mangroves Area. Several positive changes include:

- 1) The introduction of numerous cleanup tools has facilitated the cleanup process for everyone.
- 2) Through extensive awareness campaigns, local residents have ceased littering in beach areas, and food stall owners have discontinued the use of plastic.
- 3) To promote awareness, informational boards with the message "NOT TO THROW PLASTIC IN THIS REGION" have been prominently displayed on the beaches.
- 4) Initially, there was no participation from the Corporation's Swachhta Karmachari (cleanliness workers) during our cleanup drives. However, after persistent follow-ups, we secured the support of the entire Corporation squad, leading to increased involvement in cleanup activities. Additionally, For Future India has played a role in generating employment within the Corporation.
- 5) Following extensive paperwork with the Corporation, we have acquired various machinery, including a Cleanup compactor machine, Tractor, JCB, and Tractor-towed beach cleaner.



Mangroves Cleanup & Conservation

"Save Mangroves, Save Earth"

Mangroves, vital coastal ecosystems, face significant threats from deforestation stemming from various human activities such as agriculture, aquaculture, and urban development. Over the past half-century, these factors have contributed to the loss of more than a quarter of mangrove forests worldwide. Disturbingly, 62% of this loss can be attributed to human causes, primarily agricultural and aquacultural practices.

Recognizing the critical importance of mangroves in mitigating coastal erosion, preventing seawater intrusion, and providing natural barriers against the impact of tsunamis, our organization has embarked on a mission to raise awareness about their invaluable ecological roles. Through concerted efforts, we aim to highlight the benefits of mangroves to our local communities, emphasizing their crucial role in sustaining coastal biodiversity and protecting shorelines.

Over the past four years, 'For Future India' has spearheaded mangrove conservation initiatives under the banner of 'Mangrove Warrior,' focusing on key areas such as Mira Bhayandar Region, Gorai Khadi, and the Manori Mangrove Region. Through these endeavors, we have successfully mobilized college and school students, as well as local residents, to actively participate in mangrove forest cleaning campaigns. Together, we have achieved remarkable milestones, including the removal of over 1000+ tons of garbage from these vital ecosystems.

In accordance with India's Coastal Regulation Zone Notification, 2011, which falls under the ambit of the Environment Protection Act, 1986, mangrove ecosystems are afforded legal protection. Our organization is committed to upholding these regulations, categorically opposing any destructive activities in and around mangrove areas. We vigilantly monitor and intervene in instances of violation, ensuring the enforcement of protective measures for mangrove ecosystems.

Furthermore, we actively engage in mangrove protection and restoration efforts, working tirelessly to safeguard these precious habitats for future generations. Our commitment extends to the proactive planting of mangroves, contributing to the expansion and rejuvenation of mangrove forests along our coastlines. Through our multifaceted approach, we endeavor to not only conserve existing mangrove ecosystems but also to actively participate in their restoration and expansion, safeguarding their invaluable ecological services for the benefit of all.

InterCollege Competition

Timing - 7am to 11am

CPL as an inter-college competition is a medium to create awareness about cleanliness and plastic freedom in society through youth participation. Our sincere effort in the competition will help connect the youth with the Swachh Bharat mission. This competition is being organized by 'For Future India' to combat the problem of ocean pollution and the increasing amount of plastic in marine waste. We believe that this competition will create massive awareness and massive behavioural change about how the use of plastic is harming our marine life.

About the Competition :-

Any college can participate in this CPL inter-college competition. Since the number of competing teams is fixed, first valid registrations will be considered. It shall be mandatory for the competing team to provide correct information about the college and volunteers in the registration. The college will be expected to appoint a team captain who will do the coordination properly. It should be noted that no registration fee or other charges will be charged in CPL Intercollege Competition. In addition to the number of volunteers present and waste collection during the competition, the quantity of kilograms of Eco boxes collected in colleges over a period of 7 days will also be considered as a winning criterion (Eco Box Collection starts from 16th February to 22th February. Pickup of Eco boxes on 22th or 24th February).

Rules & Regulations

1. Team registration with accurate information is mandatory.
2. Apart from the registered volunteers, the team may involve other volunteers in the cleanliness drive keeping in mind the issue of public awareness. The number will be calculated by taking into account the external volunteers.
3. It will be mandatory to submit volunteers attendance (i.e via Google Form) and group photo along with the banner after each cleanliness drive.
4. E-Certificate will be issued to the volunteers of each Cleanup drive after receiving the Attendance form.
5. The schedule of the cleanliness drive will be announced before the start of the competition, CPL Management will have the decision to change the schedule and select a cleaning campaign
6. The management will provide each team with necessary materials for the cleanliness drive, including gloves, other clean-up tools and a first aid kit for precaution.
7. Volunteers participating in the cleanliness drive should wear comfortable attire and bring their own drinking water bottles. Please be advised that travel expenses will not be reimbursed by the management.
8. The decisions made by the Management Team are final and binding on all participating teams
